The Exemplary Sexual Health Education (ESHE) Convening Meeting (Convening) will bring together State Education Agency (SEA) partners funded by the CDC/DASH PS13-1308 Cooperative Agreement. SEAs will engage in professional development and peer-to-peer learning opportunities over two days. We will give special attention to specific required ESHE activities and implementing sustainability practices as first presented at the 2016 SEA Institute. In addition, SEAs will explore storytelling as a communication tool for sharing compelling stories to their stakeholders about PS13-1308 activities.

Meeting Goal

The 2017 ESHE Convening will increase capacity of SEAs to sustain PS13-1308 ESHE activities through focused strategies within 4 OAH sustainability factors.

Meeting Outcomes

- 1. To increase capacity of SEAs to integrate programs or services into local infrastructures for the institutionalization of teacher professional development. (OAH Factor 5)
- 2. To increase capacity of SEAs to secure community support of PS13-1308 ESHE activities through the communication tool of "Storytelling". (OAH Factor 4)
- 3. To increase capacity of SEAs to build a leadership team to support PS13-1308 ESHE activity sustainability. (OAH Factor 6)
- 4. To increase capacity of SEAs to create strategic partnerships to support PS13-1308 ESHE activity sustainability. (OAH Factor 7)
- 5. To increase capacity of SEAs to create strategic partnership with SEA, NGO, and PLC at ETR colleagues to support PS13-1308 ESHE activity sustainability. (OAH Factor 7)
